(since early 2020). we discovered some wood rot in the kitchen island. we brought an exterminator out to examine it and there was no current presence of bugs of any kind. We did further prevention treatment and have seen no evidence of any bugs - termites or otherwise.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.
